



Booking terms and conditions

Usage policy

County Campsite Carwynnen is open to all members of Girlguiding, Scouts, uniformed organisations, charitable groups and other youth organisations including schools/educational and Duke of Edinburgh groups for overnight/residential stays and day bookings. Carwynnen is also open to external groups and organisations e.g. walking groups, arts groups, forest schools etc.

For Girlguiding users:

For events involving an overnight stay someone in the event leadership team must hold, or be working towards, the relevant modules of the Going Away With Scheme. Approval must be gained from their Commissioner as per the current Girlguiding policies.

Girlguiding UK Insurance only covers Girlguiding members during Guiding activities. All groups must provide their own adequate insurance while on site.

For non-Girlguiding users:

To comply with health and safety regulations the hirer must protect Girlguiding Cornwall against all losses while they are using Carwynnen Campsite. This includes damage to the site or to any property belonging to the owners and against all claims made by any person for personal injury or loss of or damage to any other property arising out of the hiring and caused by the negligent act, error or omission of the hirer, or the servants or agents, or members or guests of the hirer.

Liability insurance:

The hirer must take out and maintain an insurance policy covering third party liability, including all liabilities referred to above, for a limit of indemnity of not less than £5,000,000 (five million pounds) in force for the period of hiring. A copy needs to be forwarded to the booking secretary with payment.

Booking terms and conditions

Making a booking:

- Bookings can only be made if you are 18 years or older.
- The website shows AVAILABILITY for Carwynnen Campsite. Provisional bookings can be made by submitting a Booking Form; this does not guarantee a booking.

Booking confirmation:

- Once the online Booking Form has been completed, your dates will be checked and booking confirmed and invoice sent by email. This will happen within 3 working days.
- Camping – A deposit of £30 is required within 3 weeks of receipt of your invoice, to secure your booking.
All camping fees need to be paid in full 1 week before arrival.
- Day hire – Full payment is required within 1 week of receipt of your invoice.
- Payments can be made via BACS or cheque. Details of how to pay will be on your invoice.
- Camping – The remainder to be paid after your stay on site and the electricity used has been added on.

Changing a booking:

- Dates can only be changed if there is availability and at the discretion of the booking secretary.
- Numbers can be altered right up until the day of use.
- Day users – if numbers exceed the 30 people on the day or your session time runs over, you will be invoiced for the additional people and/or usage after the event.

Cancellation:

- It is the users' responsibility to arrange appropriate insurance against cancellation.
- Any breach to the terms and conditions listed above may result in your booking being cancelled; no refunds will be given.

Cancellation by you, the user:

Cancellation of confirmed bookings must be sent to the booking secretary in writing (email or post).

- Cancellation 14 days before the booking date, the deposit will only be returned if a replacement booking is made.

- Non-arrival or cancellations 14 days or less from the date of arrival you are liable for the full cost as per your booking invoice.

Cancellation by Girlguiding Cornwall (Carwynnen Campsite):

If Girlguiding Cornwall, Carwynnen Campsite, should cancel your booking for any reason then you will be refunded in full any monies paid, within 28 days.

The hirer will not receive compensation for any cancellation other than the refund of fees paid.

Data protection: Your data will be held on a Google Form which is only accessible by the booking secretary and treasurer for Carwynnen, but may be shared to any other committee member should the need arise. Your data will only be used in relation to your booking.

Finally:

The booking secretary will be in touch with the Visitors pack once booking is confirmed.

This will include:

- Site location
- Site information
- Arrival and departure information
- Fire safety
- Risk assessment
- Hire agreement

Pricing 2024

Camping:

£5.00 per night per person for Girlguiding members.

£6.00 per night per person for Scouts, uniformed organisations, charitable groups and other youth organisations including schools/educational and Duke of Edinburgh groups.

£7.00 per night per person for all other users.

Pricing 2025

£5.00 per night per person for Girlguiding members.

£7.00 per night per person for Scouts, uniformed organisations, charitable groups and other youth organisations including schools/educational and Duke of Edinburgh groups.

£8.00 per night per person for all other users.

£10 per person per night for Tented Village, which includes all the tents you require, already erected on-site ready for use.

Daily session hire:

£15 per session for up to 30 people. Over 30 people add 50p per person per session.

Session times are:

9am -1pm

1pm-5pm

5pm-11pm

Electricity:

Everyone is required to pay £0.80 per unit of electricity used.

Deposit:

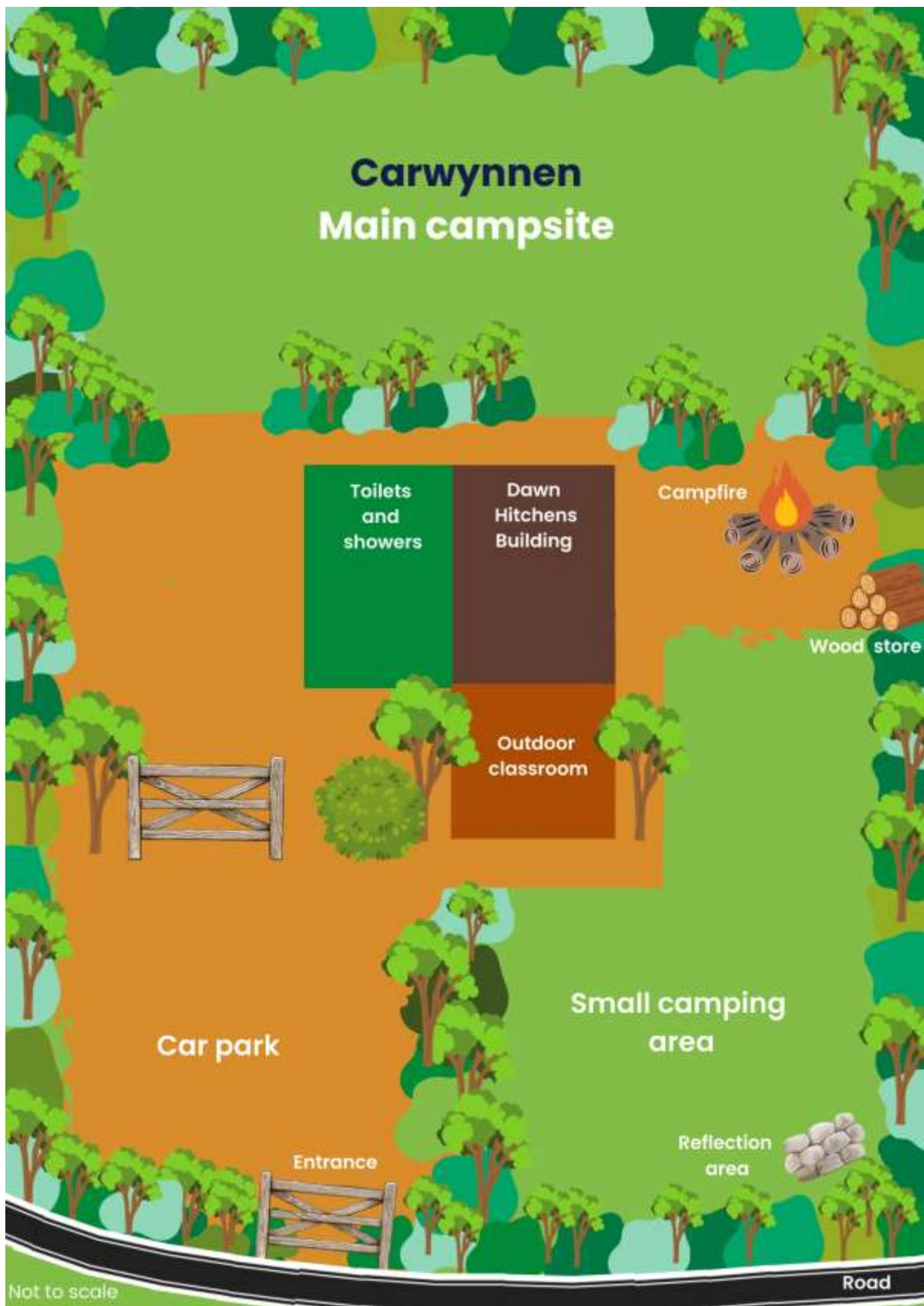
A deposit of £30 is required when the booking for camping is confirmed.
